Registering for a Housing Online account

1. You need to click on the Housing Online link (circled below) on the Nottingham HomeLink website: www.nottinghamhomelink.org.uk

Log in and create account carefully choosing one of the following options:

Option 1 - I don't have a Housing Online Account and I am a Nottingham City Council / Nottingham City Homes Registered Provider Ltd tenant / leaseholder OR I don't have a Housing Online Account, but I do have a 'live' HomeLink application.

This option is for current Nottingham City Council / Nottingham City Homes Registered Provider Ltd tenants or leaseholders. This also includes Nottingham City Council / Nottingham City Homes Registered Provider Ltd tenants who want to register a housing application for a transfer OR for current HomeLink applicants with a 'live' active application and you want to place weekly bids.

OR

Option 2 - I don't have a Housing Online Account and I'm not a Nottingham City Council / Nottingham City Homes Registered Provider Ltd tenant / leaseholder or an existing Homelink applicant.

This is for anyone who is NOT a Nottingham City Council / Nottingham City Homes Registered Provider Ltd tenant or leaseholder or an existing Homelink applicant.

Once fully verified, you can go back into Housing Online and log in using your email and password.

5. Once you have successfully created a Housing Online account you can then log back in and complete the series of question to see if you are eligible to progress your housing request by clicking the **Housing Options** tile.

When you apply to join the Housing Register, we need you to send us various identification documents, so we can process your application. You must send us your identification immediately so that we can use it to help us to process your application.
